



## FOSTER AGREEMENT

MAC and the undersigned person, hereinafter referred to as the foster, promise to agree and be legally bound by this agreement under the following terms and conditions.

**Foster Care:** You will provide care for the animal you agree to take and we agree to place in your home at the address found on the bottom of this agreement. It is important to remember these animals may be frightened and confused. MAC suggests you segregate this animal for a short period until the animal can be evaluated by yourself and a licensed veterinarian. The noted segregation period affords the animal time to become comfortable in its surroundings and the foster time to evaluate the animal. Even with this precaution you are assuming a risk. MAC will not be liable for any claims concerning this undertaking.

The foster will provide the following for this animal:

- Clean drinking water and wholesome food appropriate to that particular animal
- A clean and safe environment inside your home
- A clean and safe place for elimination
- Transportation to and from the veterinarian
- Administering medication should that be necessary
- Monitored daily exercise in the form of walks and/or play in a secured yard.
- Socializing and basic training
- Evaluation of that animal to be reported to MAC regularly
- A crate or confined place inside the home where the animal can be safely kept if left alone.

If a crate is used for housetraining purposes, that crate will allow the animal movement without allowing elimination

- A safe place is defined by an area restricting the animal from the main body of the home that keeps them safely confined. A bed, matter for elimination and water will be included in that area
- Adult animals may not be crated for more than 8 hours per day and not for greater than 4 hours at a time, but may be crated overnight. Puppies under the age of 6 months may not be crated longer than their age in months. Very young puppies under the age of 2 months may not be crated for more than two hours without regular breaks.

**We require that you notify MAC before vacations to inform us of arrangements made for the animal. If MAC needs to provide temporary fostering please advise two (2) weeks before your vacation.**

**Veterinarian Care and Expenses:** MAC will be responsible for all medical care for the animal placed in your home. You must immediately notify MAC of the need before an appointment is made. MAC will require a copy of the veterinarian's bill for reimbursement if MAC's account is not billed. All MAC board member phone numbers will be provided to you in case of an emergency.

I AGREE TO NEVER LET THE Michigan Animal Crew ANIMAL OFF A LEASH UNLESS IN AN AREA THAT IS COMPETELY FENCED AND SECURE. IF THE DOG IS LOST, Michigan Animal Crew MUST BE IMMEDIATELY NOTIFIED. \_\_\_\_\_ ← Initial Here

I further understand and agree to allow a Michigan Animal Crew representative to conduct all investigations and preparations for placement of the animal. I agree to cooperate fully with all Michigan Animal Crew guidelines with respect to care of the animal and will comply with home visits, follow-up phone calls, and all adoption procedures. I agree to surrender the animal to Michigan Animal Crew if I am found to be in violation of any of the above terms, to be determined at the sole discretion of Michigan Animal Crew, or at any such time that Michigan Animal Crew requests the animal be returned to Michigan Animal Crew's care. Should I wish to adopt the Michigan Animal Crew animal in my care, I understand I must notify Michigan Animal Crew immediately and realize placement will be based on what is best for the animal's welfare as determined by Michigan Animal Crew. If deemed qualified by Michigan Animal Crew to adopt said animal, I will be responsible for payment in full for the animal's nonnegotiable adoption fee assessed by Michigan Animal Crew, as well as fulfillment of all contractual adoption obligations and requirements as stipulated by Michigan Animal Crew.
